**ORDER:**

The Secretary/ Correspondent of **The Vivekananda Vidya Samastha Society, D.No.6/56, Main Bazar, Vinukonda, Palnadu District, A.P** has applied for the establishment of New Private Unaided Law College by name **A & A College of Law, D.No.222/1A, Narasaraopet Road, Vittramarajupalli (V), Vinukonda (M), Palnadu District, A.P** for the academic year 2024-25 vide reference 4.

The AP State Council of Higher Education, in accordance in exercise of the powers vested in it vide reference 3, orders of the Hon'ble High Court vide reference 5 and the report of the JIC vide reference 7 hereby accords provisional permission to **The Vivekananda Vidya Samastha Society, D.No.6/56, Main Bazar, Vinukonda, Palnadu District, A.P** for starting a New Private Unaided Law College by name **A & A College of Law, D.No.222/1A, Narasaraopet Road, Vittramarajupalli (V), Vinukonda (M), Palnadu District, A.P** from the academic year 2025-26 as per the details given below:

The Permission accorded is subject to the fulfillment of the following conditions:

- 1 **The Management should obtain prior affiliation for the college, programmes with combinations, intake and medium of instruction from the concerned University and approval of affiliation from Bar Council of India during the academic year 2025-26, failing which the permission accorded is deemed to be cancelled without any further notice.**
- 2 APSCHE/ University reserves the right to conduct surprise checks at any time and the right to cancel permission/ affiliation of the college at any stage, if it is found that the documents produced by the Management are false, interpolated and improper and the Management is unable to run the college as per the norms of the Government, BCI and academic stipulations of the concerned University, apart from any defaults/ irregularities committed would attract legal proceedings under General Law.
- 3 The Management should renew their affiliation each academic year by the concerned University until permanent affiliation is generated.
- 4 The staff appointed should be qualified as per the rules and regulations furnished from time to time by the University/ Government/ BCI.
- 5 The Management shall follow the rules issued by the Government from time to time with regard to reservations in respect of admissions of students and appointment of staff.
- 6 Infrastructure like Buildings, Land, Playground, Lab equipment, Library, Furniture etc., should be well maintained for the effective functioning of the College.
- 7 The Management should not make any claim for any grant-in-aid either now or in future.
- 8 Without prior permission of the AP State Council of Higher Education/ Government of Andhra Pradesh, the College (a) should not be shifted to any other place: (b) should not change of the name of the College, (c) should not transfer the Management of the College and (d) should not convert Women's college to Co-Education and vice-versa.
- 9 If the Management is permitted to start the college in rented building they should construct permanent building for the college in their own land within a period of five years.
- 10 The accommodation shown for the Law College should not be used for any other purpose other than running the Law college for which permission is given by the APSCHE.
- 11 The Management should not change of the Programme (s), intake and medium sanctioned in these proceedings without prior permission.
- 12 The Management shall provide adequate building accommodation for the programmes sanctioned.
- 13 The Management of the college shall set up a grievance and complaints cell as per the Supreme Court guidelines for dealing with sexual harassment related cases and action should be initiated against erring individuals without any delay.
- 14 The Management of the college shall not affiliate itself to any University outside the State of Andhra Pradesh U/s 21-A of AP Education Act 1982.
- 15 The Management should establish a website for the college and keep all the necessary academic and administrative information in the website.
- 16 The Secretary/ Correspondent, of the college is informed to exercise his powers as per the provisions of the AP Education Act 1982.
- 17 The College shall not make admissions into the Programmes sanctioned in these proceedings until issuance of affiliation order by the concerned University and approval of affiliation from Bar Council of India, New Delhi.
- 18 The Management of the college shall obtain Fire Safety certificate for the college building.
- 19 The Management of the College shall provide parking area within the premises of the college/ within 5km from the college building to an extent of 20% of the total built-up area.



- 20 If the Management either fails to fulfil any of the conditions mentioned above or violates rules/ guidelines laid down by University/ Government/ APSCHE/ BCI, issued from time to time, the permission granted will be withdrawn.
